This is the big one. They're going for broke... I think we may only have potentially until May before one or both of these documents gets voted on" — Meryl Nass, M.D. and James Corbett continue their discussion on the WHO's proposed International Health Regulation Amendments + potentially legally-binding 'Zero Draft Treaty' currently being drawn up in secret meetings behind closed doors. As the WHO touts the solution to worldly problems as possible through their 'One Health' approach — one wonders if a world in which humans, animals, agriculture, and weather are dominated by state depicted notions of the highest attainable standard of 'health' may secretly be a trojan horse to dominate as much of the sovereign world as possible — usurping power from individual countries and thrusting it into the hands of a mad-with-power agency which seeks to control Earth's resources, ecosystems, food, animals, and plants.

From the web page:

7 December 2022,

Countries meet for three days to agree next steps toward historic legal instrument, rooted in the WHO Constitution, designed to protect world from future pandemics.

During discussions, Member States call for global agreement that takes into account equity, promotes preparedness, ensures solidarity and respects sovereignty.

Zero draft of the pandemic accord to be ready for negotiations by Member States starting February 2023.

In December 2021, at its second-ever special session, the World Health Assembly established an intergovernmental negotiating body (INB) to draft and negotiate a convention, agreement or other international instrument under the Constitution of the World Health Organization to strengthen pandemic prevention, preparedness and response. The INB's work is based on the principles of inclusiveness, transparency, efficiency, Member State leadership and consensus.

The PDF has a nice clickable table of contents on page 4. Below I will comment on a random few items. But don't trust my interpretations. Check it out for yourself.

Article 4. Principles

Item number 3, referring to the language of the Charter of the United Nations says (my highlight in italics):

Sovereignty – States have, in accordance with the Charter of the United Nations and the principles of international law, the sovereign right to determine and manage their approach to public health, notably pandemic prevention, preparedness, response and recovery of health systems pursuant to their own policies and legislation *provided that activities within their jurisdiction or control do not cause damage to other States and their peoples.*

Article 24. Withdrawal

This section says a party to the agreement can only file for withdrawal after minimum 2 years and then can withdraw one year later; in other words it takes a minimum of 3 years to get out of the treaty.

Article 26. Amendments to the WHO CA+

This section says amendments to the agreement can be passed by 2/3 majority. This means those not in favor of an amendment will be party to something they don't agree with for at least 3 more years.

Article 16. Strengthening pandemic and public health literacy

This section is all about the efforts at propagandizing their population expected of countries who are party to the agreement. Media "literacy" is needed to avoid mis- and dis-information.

Several items from the section:

Towards this end, each Party [shall]/[should]:

(a) Inform the public, communicate risk and manage infodemics through effective channels, including social media;

(b) Conduct regular social media analysis to identify and understand misinformation, and design communications and messaging to the public to counteract misinformation, disinformation and false news;

(f) Strengthen research into the behavioural barriers and drivers of adherence to public health measures, confidence and uptake of vaccines, use of therapeutics and trust in science and government institutions.

Article 17. One Health

This section refers to urging parties to "Promote and implement a One Health approach" which presumably refers to the One Health concept as described further down. From that section:

Towards this end, each Party [shall]/[should]:

(g) Strengthen synergies with other existing relevant instruments which address the drivers of pandemics, such as climate change, biodiversity loss, ecosystem degradation and increased risks at the animal-human-environment interface due to human activities;

This Review Committee will function in accordance with the [WHO Regulations for Expert Advisory Panels and Committees](#), and will provide its report to the WHO Director-General no later than mid-January 2023.

The sole purpose of this Review Committee is to provide technical recommendations to the Director-General on amendments proposed by State Parties to the IHR.
