## Introduction

The World Health Organization has in the years since the rollout of Covid stepped up their plans to make a "Pandemic Treaty" and to amend the 2005 International Health Regulations.

The treaty and the proposed amendments would greatly expand on the power over people's lives that the WHO has - far beyond what we've already seen during the "pandemic". Treaties need to be ratified but the amendments to the IHR can be made and finalized without being agreed upon in any democratic process open to the people of the world. Lots of people need to be aware of this in order to stop it and the WHO itself.

To give you an idea of what is being proposed here is an ominous teaser. Near the beginning of the now existing International Health Regulations, the first paragraph of Article 3, titled "Principles", is one line ensuring basic rights, but the "fundamental freedoms of persons" would be deleted and replaced with a communitarian appeal to the greater good. The [blue text](#) would replace the crossed out text:

1. The implementation of these Regulations shall be ~~with full respect for the dignity, human rights and fundamental freedoms of persons~~ [based on the principles of equity, inclusivity, coherence and in accordance with their common but differentiated responsibilities of the States Parties, taking into consideration their social and economic development.](#)

(Note: In the final version of the item above, the crossed-out part remained and they added only "and shall promote equity and solidarity.")

Note that this PDF is one person's work; material I have discovered and been exposed to. The reader is urged to do their own research. There's lots of good people working hard on this, but time is of the essence. Please spread the information far and wide.

Finally a shout out to James Roguski for many of the sources and for all of his great work. He is the foremost champion of the fight against this branch of the Global Coup.

# Post 77th World Health Assembly Reorganization of This PDF

As of June 15, 2024, this document is going to be re-organized.

The 77th World Health Assembly took place the last week of May, 2024 where it had been anticipated that the WHO would try and amend the 2005 International Health Regulations and would try and establish a new pandemic treaty.

The WHO seemed to indicate that they had failed to accomplish their goals; they did in fact publish one statement, "The INB did not reach consensus on the text." There was a general upbeat feeling among many following the developing story that we had won. Meryl Nass, one of the two people I know of who has been fighting hard against the WHO's plans, titled a May 27th article, *The WHO's Pandemic Preparedness agenda has FAILED. YES, NOW! I explain why. Don't be fooled.*

James Roguski, who has been deeply into the nuts and bolts of the WHO's shenanigans for years, disagrees. In fact, he thinks they accomplished their goals.

As a consequence of a completely new look to this arm of the Global Coup, this PDF is being re-organized. It will be in 2 main parts.

The first part, *Post 77th World Health Assembly*, will be information updates and also include the section, *Resistance, being Proactive*, which will likely be updated also.

Following its mandate as set out in decision SSA2(5), the INB [the intergovernmental negotiating body they set up in 2021] drafted and negotiated the text of the WHO Pandemic Agreement, the draft of which, as at the conclusion of its ninth meeting, is contained in the Appendix. The INB did not reach consensus on the text.
