Preface

When the rollout of Covid woke me up to the bigger global agendas that were at play, I began to pay attention to the players whose names seemed to surface over and over again. One that I noticed was Johns Hopkins.

I first heard of them as the "hosts" of Event 201, which was a pandemic scenario "tabletop exercise" which they carried out in partnership with the World Economic Forum and Bill Gates, two of the heavies among the megalomaniac technocrats involved in the Covid psyop and much more before and since.

This PDF will not deal with either the WEF or Bill Gates except peripherally; to learn more about either of them check out several PDFs about them, all found in my [Technocracy, World Economic Forum](#) page on my Quasar website.

It turns out that Johns Hopkins was host of three other tabletop exercises before Event 201 and one more since then. These will be the main topic of this paper following first a look at Johns Hopkins; what they are about, their funding, and a little history.

First, a Subjective Overview of Johns Hopkins

Johns Hopkins' full name is actually *Johns Hopkins, Bloomberg School of Public Health*, and is part of the *Center for Health Security*.

As mentioned in the preface Johns Hopkins is involved in many collaborations or Public-Private Partnerships with many other players involved with technocratic machinations. It should be clear, as their full name indicates, that Johns Hopkins is a Michael Bloomberg organization. Bloomberg is a billionaire and also a major player in league with Bill Gates, Soros and others in the club.

Since Covid it has become completely transparent that the major "health" oriented organizations are basically oriented to the Hegelian Dialectic of Problem, Reaction, Solution. The problem is predominantly presented as viruses and pandemics. The cultivated reaction is that the public should be fearful. And the solution is that vaccines are here to save the day as well as other necessary public health measures such as those we endured during Covid.

This is Johns Hopkins' focus. Unfortunately, as we also saw during Covid, these people created the problem. Covid was utterly unreal; a complete fake. Much of what concerns

Johns Hopkins is that the **P**roblem of killer diseases and the **R**eaction of fear be maintained. That is the essence of their tabletop exercises. They are game playing scenarios in what we are told is an increasingly dangerous world of pandemics.

As you will see reflected in their tabletop exercises, on par with and parallel to their fear of viruses, they also sell the fear of mis- and dis-information, saying it undermines trust in public health authorities, which is, ostensibly, so critical in a public health crisis.

On their [Our Work - Research Projects](#) page on their website they showcase numerous projects. As of this writing two of the top four that they feature are directly propaganda related. One is titled [*Tackling Rumors and Understanding & Strengthening Trust \(TRUST\) in Public Health*](#) - Supported by: Centers for Disease Control and Prevention (CDC) of the US Department of Health and Human Services (HHS). The other is [*Addressing Health-Related Misinformation and Disinformation*](#) - Supported by: US Centers for Disease Control and Prevention (CDC), Johns Hopkins University Catalyst Award, National Academies of Science, Engineering and Medicine (NASEM), and Open Philanthropy.

I leave it to the reader, if interested, to explore those projects but suffice to say it's the same old, same old - they position themselves as the arbiters of truth and any information contrary to their narrative is positioned as harmful and dangerous.

Why Johns Hopkins Whole Premise is a Ruse

In recent years I have been exposed to information that has led me to change my beliefs about viruses in general. There are many learned and aware people, trained in medicine, who understand how the body functions (which most doctors don't), and who believe that there is no such thing as a contagious virus.

I, personally, have never feared viruses (didn't have any idea what they were supposed to be, before Covid) and though I believed in contagion I always viewed being "sick" as my body throwing something off in order to get better, as opposed to being under assault from a pathogen.

The concept that viruses don't exist might be challenging, as most of us have lived our whole lives with the idea, imparted culturally by osmosis, of "catching" things, but, at this point, I am quite convinced that contagious viruses don't exist and extremely convinced they have never been proven to exist.

But the most important central thing is the exposing of the fact that never has a virus been isolated. This is incredibly important because, if true, everything that hinges on fearing contagious disease - social distancing, lockdowns, monitoring, surveillance, digital

passes, and the push to get people to exchange a real social life for a "virtual" one, etc. - are all downstream from this. And along with that goes the learning of how the *bad guy bug* and the *good guy drug* concept was a seminal feature of the psyop that was at the heart of the creation of Western Medicine's stranglehold on everything health related.

Among those ten academic divisions are the School of Medicine, the Applied Physics Laboratory, and the Bloomberg School of Public Health, which has a division called the Center for Health Security, which is responsible for the tabletop exercises.

The Center for Health Security began as the Johns Hopkins Center for Civilian Biodefense Strategies (CCBS) in 1998 at the Johns Hopkins Bloomberg School of Public Health. D. A. Henderson served as the founding

director. At that time, the center was the first and only academic center focused on biosecurity policy and practice.

At one point around 2003, CHS had become part of a new umbrella organization called the Institute for Global Health and Security at the Johns Hopkins Bloomberg School of Public Health.

Funding -

In 2002, the center received a \$1 million grant from the US federal government.

Before 2017, CHS was heavily reliant on government funding.

In January 2017, the Open Philanthropy Project awarded a \$16 million grant over three years to the Center for Health Security. Another grant of \$19.5 million was awarded in September 2019.

On November 18, 2018, it was announced that Michael Bloomberg would make a donation to his alma mater of \$1.8 billion, marking the largest private donation in modern history to an institution of higher education and bringing Bloomberg's total contribution to the school in excess of \$3.3 billion.

Introduction to the Tabletop Exercises

It's hard to pin down exactly what the purpose of these tabletop exercises is. Ostensibly it's for them, the "experts", to grapple with the scenarios which may arise and game out the best ways to overcome issues and successfully, as best possible, to deal with the pandemic or bio-threat.

In reality, their purpose seems to be to legitimize the Public Health Measures and, of course, the vaccines, while at the same time bringing attention to the dangers of mis- and dis-information and the public's failing to comply with health authority recommendations.

Also a recurring theme is that the involved agencies are ill prepared and underfunded to deal with the sure to come outbreaks or bio-terror; this being a call for more funding and bigger bio-security state infrastructure.

These elements are what I will show in excerpts from the exercises. Note that in the Wikipedia link above it indicates that the Center for Health Security gives policy "recommendations" to the United States government and the World Health Organization. Keep in mind, that although Johns Hopkins itself can't mandate public health measures, another reason for these exercises is to support the adoption of their recommendations by like minded individuals in the so-called public health sector.

The Five Tabletop Exercises Overview

This section is the overview, as per their website, except here they are listed in chronological order, whereas on their website they are in reverse chronological order. The titles link to the sections for each of the exercises further down.

June 22-23, 2001

The Dark Winter exercise portrayed a fictional scenario depicting a covert smallpox attack on US citizens. The scenario is set in 3 successive NSC meetings that take place over 2 weeks. The exercise was held at Andrews Air Force Base, Washington, DC.

October 18, 2019

The Johns Hopkins Center for Health Security in partnership with the World Economic Forum and the Bill and Melinda Gates Foundation hosted Event 201, a high-level pandemic exercise on October 18, 2019, in New York, NY. The purpose of the exercise was to illustrate the pandemic preparedness efforts, response decisions, and cooperation required from global businesses, governments, and public health leaders that the world will need to diminish the large-scale economic and societal consequences of a severe pandemic.

The Johns Hopkins Center for Health Security, in partnership with WHO and the Bill & Melinda Gates Foundation, conducted *Catastrophic Contagion*, a pandemic tabletop exercise at the Grand Challenges Annual Meeting in Brussels, Belgium.



The Five Tabletop Exercises

Here, in chronological order, the exercises are reviewed.

This is not intended to be a deep look at all of the details or the players, rather as an introduction to the nature of each of the exercises, as well as a look at the options they consider, ostensibly to control the pandemics but in reality, the populace.

Dark Winter

June 22-23, 2001

Dark Winter was hosted by the Johns Hopkins Center for Civilian Biodefense Studies and three other organizations:

- The Center for Strategic and International Studies
- Analytic Services, Inc. (ANSER)
- The Oklahoma City National Memorial Institute for the Prevention of Terrorism

The Dark Winter exercise portrayed a fictional scenario depicting a covert smallpox attack on US citizens. The scenario is set in 3 successive NSC meetings that take place over 2 weeks. The exercise was held at Andrews Air Force Base, Washington, DC.

Note that Dark Winter was just 2 months before 9/11 and the anthrax scare that followed, just as Event 201 preceded the rollout of Covid by about 3 months.

Curiously, the way they set the stage it seems like they may be building a case to intervene in the Middle East. They set the stage with all the usual suspects being the belligerents:

- Relations between Taiwan and China are going to hell and Taiwan has an outbreak of Hoof and Mouth disease devastating their swine industry and they think China caused it. Iraq masses troop on the Kuwaiti border. Kuwait wants western help. Russian and China oppose that.
- A close friend of Osama Bin Laden was caught trying to smuggle 50 kilograms of plutonium. From the script:

Six months ago, the US lifted sanctions against Iraq and ceased enforcement of the “no-fly zones”. Saddam has since pursued an aggressive effort to upgrade military forces and has imported equipment and materials that might be used to build chemical or biological weapons.

- Smallpox breaks out in several US states and they think it's an act of bioterrorism.

The President:

This is an extremely serious situation. Smallpox no longer exists in nature. Presumably, this disease has been deliberately introduced and these cases are the result of a bioterrorist attack on the United States.

The Governor of Oklahoma:

It appears my state has been attacked with a smallpox weapon. We are not sure yet how many people are affected. Media have been barraging our public affairs office for comment since CDC confirmed the diagnosis an hour ago. We understand that the emergency rooms in Oklahoma City are extremely crowded.

Then there is a section with lots of bad news about food shortages, vaccine shortages, civil unrest, etc.:

- US Smallpox Cases Mount; Congress Demanding Retribution
- Hospitals Overwhelmed; Care Suffering
- Mothers Plead for Vaccine as Supply Dwindles
- Violence Breaks Out at PA Vaccination Sites
- Borders Closed to US Trade
- Government Response Criticized
- Food Shortages in Some Cities; Many Restaurants Close
- Governor Considers Closing Stores to Halt Disease Spread
- DOD Reluctant to Release Assets for Civilian Use
- National Guard Invaluable in Crisis; Special Teams of Little Use

What to Do About It

Now that all hell has broken loose, it's time for the government to take control.

Throughout the script, they toss around ideas about what they might be able to do legally and suggest actions. To those ends they cite a number of laws in existence (real laws - not pretend like the exercise) that a threat to public health would allow them to use:

The Posse Comitatus Act (18 U.S.C. § 1385) - Federal troops (incl. Federalized National Guard) may be used for law enforcement if the President invokes the Insurrection Act to quell civil disturbances.

The Federal Quarantine Law (42 U.S.C. § 264) - Judicial decisions indicate that forcible inoculation and quarantine of infected patients may be constitutional.

The Insurrection Act (10 U.S.C. § 331 et seq.) - The President may use the military (including the Federalized National Guard) to quell (1) civil disturbances in a State (upon the Governor's request).

32 C.F.R. § 501.4: "Martial law depends for its justification upon public necessity. Necessity gives rise to its creation; necessity justifies its exercise; and necessity limits its duration. The extent of the military force used and the actual measures taken, consequently, will depend upon the actual threat to order and public safety which exists at the time."

And without citing laws they speculate on what might be necessary:

Disease Containment Options: Considerations:

- Assemble contacts of patients in designated sites?
- Establish national travel policies?
- Legislation to prohibit dangerous information?

Disease Containment: Deputies' Recommendations:

Encourage voluntary home isolation of contacts

Penalties for promulgating dangerous information

Establish federal travel restrictions

Cancel all public gatherings in affected states, non-essential meetings
of >50 people elsewhere

As you can see, this is pretty much like what we lived through in 2020, but it seems there are laws, that should the authorities decide to go that route, they could cite, and claim the seriousness of the situation warrants it, to be much more heavy handed than they were during Covid, at least militarily.

Atlantic Storm

Atlantic Storm was a ministerial table-top exercise convened by:

- The Center for Biosecurity of the University of Pittsburgh Medical Center
- The Center for Transatlantic Relations of the Johns Hopkins University
- The Transatlantic Biosecurity Network.

The exercise was sponsored by:

- The Alfred P. Sloan Foundation
- The German Marshall Fund of the United States
- The Nuclear Threat Initiative.

From their Overview:

The exercise used a fictitious scenario designed to mimic a summit of transatlantic leaders forced to respond to a bioterrorist attack. These transatlantic leaders were played by current and former officials from each country or organization represented at the table. There was an audience of observers from governments on both sides of the Atlantic as well as from the private sector, but the venue was designed to focus all attention on the summit principals and their discussions around the table.

This exercise seems to be far less detailed as to the background and the attack itself as was Dark Winter. It is more of a show. The webpage links to many PDFs that are guides and such to the exercise.

Clade X

Clade: klād/

A clade (from Ancient Greek: $\kappa \lambda \alpha \delta \omicron \varsigma$ or klados, meaning "branch") is a group of organisms that consists of a common ancestor and all its lineal descendants, representing a single "branch" on the "tree of life."

The Johns Hopkins Center for Health Security hosted the Clade X pandemic tabletop exercise on May 15, 2018, in the Mandarin Oriental Hotel in Washington, DC.:

Clade X was a day-long pandemic tabletop exercise that simulated a series of National Security Council–convened meetings of 10 US government leaders, played by individuals prominent in the fields of national security or epidemic response:

The purpose of the exercise was to illustrate high-level strategic decisions and policies that the United States and the world will need to pursue in order to prevent a pandemic or diminish its consequences should prevention fail.

This is, like Atlantic Storm, more like a show without all of the background and intrigue that Dark Winter offered. And with Clade X they are getting much more modern, streaming the event:

The Clade X exercise was conducted in front of a live audience of government officials, academics, and members of the health security community and streamed live on Facebook.

The Clade X website page also includes four videos being the four segments of the exercise, each being between one and one and a half hours long.

In a PDF, *A Brighter Dawn* (see link below), they give the background of the biological attack scenario the exercise is addressing:

The Clade-X adversary is a non-state actor called “A Brighter Dawn” (ABD). This fictitious organization was modeled in part on Aum Shinrikyo, the Japanese doomsday cult that developed and used chemical and biological weapons in the 1990s in Japan.

This group wants to address the overpopulation problem on Earth, but a radical group splinters off, and develops bio-weapons:

ABD’s leadership also seems to have been attracted to the concept of a biblical plague as the corrective to humanity’s excesses.

There is for Clade X an extensive list of PDFs relating to the exercise, many seemingly factual information as background that help give an idea of what they can do to address a pandemic or bio attack. One is called, *Quarantine* (see link below) where, as in Dark Winter, they make the point that most states and the federal government already have quarantine authority and it's pretty much up to their discretion as to what warrants enacting them:

State Level - Every state, the District of Columbia, and most territories have laws authorizing quarantine and isolation.

Federal Level - The Secretary of the Department of Health and Human Services (HHS) has statutory responsibility for controlling communicable disease within the United States.

Authority for isolation and quarantine is provided to the federal government through the Commerce Clause of the US Constitution.

The Centers for Disease Control and Prevention (CDC) may step in if the state government is unwilling or unable to effectively respond.

If CDC reasonably believes that a person may be infected with or exposed to a quarantinable communicable disease, CDC may apprehend, detain, or examine that person (definition of “reasonable” is provided).

Event 201

October 18, 2019, New York, NY.

The rollout of the Covid psyop energized lots of people to do research and learn about the background, of both the events that set the stage and the actors responsible for the lockdowns, the mandates, the crackdown on speech, etc.

Event 201, which was held just three months before the world was first told there was a new disease and the world would never be the same, has become well known, and is considered as a possible exercise for them to assess their options for exerting control over the population.

Also, unlike the first three tabletop exercises that involved mostly military and government, Johns Hopkins' Event 201 was done in partnership with two of the non governmental organizations which became recognized after Covid as major global players, the World Economic Forum and the Bill and Melinda Gates Foundation, and introduced us to the idea of public/private partnerships shaping global agendas.

Their introduction on the Event 201 webpage:

The exercise illustrated areas where public/private partnerships will be necessary during the response to a severe pandemic in order to diminish large-scale economic and societal consequences.

From the same Event 201 webpage, About the Event 201 exercise:

Event 201 was a 3.5-hour pandemic tabletop exercise that simulated a series of dramatic, scenario-based facilitated discussions, confronting difficult, true-to-life dilemmas associated with response to a hypothetical, but scientifically plausible, pandemic.

They start by re-enforcing a major facet of the bio-security state narrative, stating as if it's fact, that the modern world is spiraling into pandemic hell:

In recent years, the world has seen a growing number of epidemic events, amounting to approximately 200 events annually. These events are increasing, and they are disruptive to health, economies, and society. Managing these events already strains global capacity, even absent a pandemic threat. Experts agree that it is only a matter of time before one of these epidemics becomes global—a pandemic with potentially catastrophic consequences. A severe pandemic, which becomes “Event 201,” would require reliable cooperation among several industries, national governments, and key international institutions.

The Event 201 scenario:

Event 201 simulates an outbreak of a novel zoonotic coronavirus transmitted from bats to pigs to people that eventually becomes efficiently transmissible from person to person, leading to a severe pandemic.

There is no possibility of a vaccine being available in the first year.

The scenario ends at the 18-month point, with 65 million deaths.

O.K. So, what do they get out of this? In a PDF, titled, *Public-Private Cooperation For Pandemic Preparedness And Response – A Call To Action* (see link below), they make 7 recommendations. Most of them are about building up a supply of vaccines and expanding the pandemic infrastructure. #7 addresses mis- and dis-information, developing "nimble approaches" to counter information threatening to their narrative:

Governments and the private sector should assign a greater priority to developing methods to combat mis- and disinformation prior to the next pandemic response. Governments will need to partner with traditional and social media companies to research and develop nimble approaches to countering misinformation. This will require developing the ability to flood media with fast, accurate, and consistent information.

Two and a half years after the rollout of Covid, and a year or so after the lifting of restrictions and such, Catastrophic Contagion seems designed to follow up on the actual Covid response with suggestions of how they can even better control the situation.

First, their introduction from the exercise's website.

The Johns Hopkins Center for Health Security, in partnership with WHO and the Bill & Melinda Gates Foundation, conducted *Catastrophic Contagion*, a pandemic tabletop exercise at the Grand Challenges Annual Meeting in Brussels, Belgium.

The exercise simulated a series of WHO emergency health advisory board meetings addressing a fictional pandemic set in the near future. Participants grappled with how to respond to an epidemic located in one part of the world that then spread rapidly, becoming a pandemic with a higher fatality rate than COVID-19 and disproportionately affecting children and young people.

Participants were challenged to make urgent policy decisions with limited information in the face of uncertainty. Each problem and choice had serious health, economic, and social ramifications.

Compared to the four previous exercises this one is very bare bones. The website has only the above introduction and there are links to four other pages;

- Acknowledgments
- Participants
- Videos
- Lessons From the Exercise.

Compared to the previous two exercises this one's video page has only three very short videos. In the video, *The Value of Exercises*, one participant, Poh Lian Lim, who is Chair of the Independent Allocation of Vaccines Group for the COVAX Facility, gave her idea of why the exercises: "Exercises are a form of inoculation for emergencies."

In the list of the participants, we see this time it includes Bill Gates himself, as well as Tom Inglesby, the Director of the Johns Hopkins Center for Health Security, who participated in all of the other exercises in one way or another. Also there is one other notable player, Mike Ryan, the Executive Director of the WHO Health Emergencies Programme, who infamously said in a [press conference](#) during the early days of Covid, "now we need to go and look in families and find those people who may be sick and remove them and isolate them in a safe and dignified manner."

On their page, [Lessons From the Exercise](#), they stress how, in spite of what was learned from Covid, there is so much more that needs to be done:

It may seem like all these critical policy decisions have been resolved during the COVID-19 pandemic, but they have not.

The exercise raised a pivotal question: If future pandemics have a much higher lethality than COVID-19, or for example, if they affect predominantly

children, would or should countries take different, stronger, earlier measures to contain it, and what are those measures?

And on the same page, they have three paragraphs all re-enforcing the need to build a broader, more comprehensive narrative infrastructure. Each paragraph leads with one sentence in bold, shown below (but not in bold).

The first two stress their need to minimize the possibility of the truth getting out because of thinking people who don't buy the narrative.

The first one calls for more of the "science is settled" we kept hearing during Covid; a predetermined consensus:

Countries should establish a global network of professional public health leaders who can work together to improve epidemic preparedness and response and strive for consensus on scientific issues in advance of the next major outbreak.

The second propagandizes that only they have the truth, and people must be made to trust them, and no one else:

Countries should prioritize efforts to increase trust in government and public health; improve public health communication efforts; increase the resiliency of populations to misleading information; and reduce the spread of harmful misinformation.

The third re-enforces the idea that the pandemic response infrastructure must be strengthened:

WHO member states should strengthen international systems for sharing and allocating scarce public health resources.

Bonus Project: Disease X Medical Countermeasure Program

And in the running for their next tabletop exercise, one of their projects, shown on their website as a "current project", the mysterious Disease X, which is also making the rounds with all the usual suspects: The World Economic Forum, The World Health Organization, and the United Nations. It seems they are getting pro-active and working on not bothering to wait for a Problem; instead going right to the Reaction - working up fear about an unknown (i.e. completely fictitious) disease that they are sure is coming down the pike. This is also predictive programming to emphasize their certainty that pandemics are going to be more frequent.

The rest of the page is the Reaction (remember, no problem yet) - lots of viruses we don't have immunity to are comin' to get you and Solution, build a well financed infrastructure of financing for a permanent medical threat orientation.

Related to the five tabletop exercises and the fictitious Disease X, six months before Clade X, John's Hopkins published their SPARS Scenario, specifically to address the problems maintaining the narrative.

From the PDF linked to below, the Preface title and its subheading:

Possible Future in 2025: The “Echo Chamber”

Unbridled Global Access To Information Coupled With
Social Fragmentation And Self-Affirming Worldviews

The first sentence of the Preface, *Scenario Purpose* :

The following narrative comprises a futuristic scenario that illustrates communication dilemmas concerning medical countermeasures (MCMs) that could plausibly emerge in the not-so-distant future. Its purpose is to prompt users, both individually and in discussion with others, to imagine the dynamic and oftentimes conflicted circumstances in which communication around emergency MCM development, distribution, and uptake takes place.

The Preface ends with the section, *Scenario Organization & Use* :

This scenario was designed to illustrate the public health risk communication challenges associated with distribution of emergency medical countermeasures during an infectious disease pandemic. The story

is organized chronologically, and each chapter concludes with a treatment of key communication dilemmas and corresponding discussion questions.

Navigation tip: If you check out the PDF linked to below, do a search for "Food for Thought". That is where, at the end of each chapter, they ponder what communication issues they might face. Or, as their exercises demonstrate, what aspects of the narrative they might need to control.

A couple of Examples

Chapter Three: A Potential Vaccine

"How might federal health authorities respond to critics who propose that liability protection for SPARS vaccine manufacturers jeopardizes individual freedom and wellbeing?"

Chapter Four: Users Beware

"How could pre-crisis partnerships and alliances have averted the potential for inconsistent messaging around Kalocivir safety and efficacy? What are the potential effects of unaligned official messages about MCM safety and efficacy?"

Chapter Eleven: Standing in Line, Protesting Online

"Why is active monitoring of the "information sea" in which the public is swimming critical to the efforts of authorities to create conditions and provide information that support recommended public health behaviors?"

Chapter Sixteen: Antibiotics, HO!

Why were partnerships between the federal government and the information technology industry, including a number of social media companies, so vital to increasing overall uptake of the Corovax vaccine?
