The following is a list of all of the witnesses and experts that appeared in the 6 days of testimony in order of their appearance.

Day 1

[Reiner Fuellmich's Opening Statement for the Grand Jury](#)

Reiner Fuellmich is heading a team of witnesses and experts giving testimony about various aspects of the planedemic in what they call Grand Jury proceedings in the Court of Public Opinion. This video is his Day 1 opening statement outlining what they will be doing and naming the witnesses and experts who will testify.

Day 2

[Alex Thomson](#)

This is the powerful testimony by Dr. Alex Thomson. He worked for 8 years for Britain's intelligence department GCHQ. He goes deep into the history of the City of London and its incredible and broad influence, maintaining that the British Empire is still the center of the Oligarch's control of the world. A very amazing history.

[Matthew Ehret](#)

This is the testimony by Matthew Ehret. He follows Alex Thomson in demonstrating the history of the elite and their machinations to dominate and control the world.

[Brian Gerrish and Debbie Evans](#)

This is the testimony of Brian Gerrish and Debbie Evans. They reveal documents that show how that governments are using applied psychology and hypnosis to create fear and anxiety among the population.

[Whitney Webb](#)

This is the testimony by Whitney Webb regarding the role that China and China's influence played in the "pandemic" response. And she ties in the US military's role.

[James Bush](#)

This is the testimony of James Bush, former lieutenant in the US Marine Corp and worked for Honeywell and for the CDC. He talks about Dark Winter and Event 201.

[Silvia Behrendt and Astrid Stuckelberger](#)

This is the testimony first of Silvia Behrendt, then joined by Dr. Astrid Stuckelberger, both who used to work for the World Health Organization. Silvia gives insight into the workings of the WHO and its current deviation from integrity. At 36:00 she is joined by Astrid and Reiner in a very interesting roundtable discussion, talking about how the WHO supersedes national sovereignty.

This is a 13 minute excerpt from World Health Organization whistleblowers Silvia Behrendt and Astrid Stuckelberger's testimony explaining how the WHO has evolved into a body beholden to private entities and not to the populous of its member nations. It is positioned to become a central feature (even more so than it already is) of the move towards global governance.

Day 3

[Dr. Astrid Stuckelberger](#)

This is the testimony by Dr. Astrid Stuckelberger, who used to work for the World Health Organization. She reports about how the declaration of

Sars Cov2 as a "public health emergency" went against all normal WHO methodology. She also covers the use of PCR as a test.

[Ulrike Kämmerer](#)

Dr. Ulrike Kämmerer, virologist and immunologist delves into the PCR "test", exposing its shortcomings. Mike Yeadon and Dolores Cahill also contribute to a discussion about the test and Christian Drosten, the inventor of the test, who is one of the six defendants.

[Soňa Peková](#)

This is the testimony by Dr. Soňa Peková, molecular biologist. She follows Ulrike Kämmerer's testimony about the PCR with more information in her field of expertise, exposing the fraud of PCR being used as a test.

[Dr. Bryan Ardis](#)

This is the powerful testimony by Dr. Bryan Ardis. He methodically outlines what was known and acknowledged about Remdesivir by Fauci and others as they pushed it as the only treatment for Covid.

[John O'Looney](#)

This is the shocking testimony by John O'Looney. He is a British funeral director. He talks of what he has seen in the autopsies. He reports that deaths were of a normal volume until the jabs started when they skyrocketed. He talks of a man who came and instructed him to count almost anything as a Covid death, then later when the jabs started instructed him to do the opposite.

He has a practice in South Africa and since Covid hit he treated 10,000 people; the only deaths were four whose family members had them go to the hospital.

Day 4

[Dr. Alexandra Henrion-Caude, geneticist, specialist in RNA research](#)

Dr. Alexandra Henrion-Caude, geneticist, specialist in RNA research, looks at the misleading narratives around the "vaccine" and looks at the

science of the mRNA vaccine and statistics regarding the fallout from them.

[Vanessa Schmidt-Krüger, molecular biologist, cardiovascular specialist](#)

Vanessa Schmidt-Krüger, molecular biologist, specialist in cardiovascular diseases, explains why the fear of the virus is unfounded, explaining how antibodies work naturally. She then exposes the flaws and fraud involved in Pfizer's clinical trials.

[Deanna McLeod](#)

This is the testimony by Deanna McLeod, Her expertise is in preparing guidelines for clinical trials. In her testimony she explains how Pfizer's Covid vaccine trials in no way proved they were safe or effective.

[Mike Yeadon](#)

This is the testimony by Mike Yeadon, former chief scientist and vice-president of pulmonary research at Pfizer. As someone from inside the industry he points out the numerous failures in the "vaccine's" design and in production as well as the virtual absence of rational regulatory procedure. Also he says there's no way they could have gone into the volume of mass production they did as quickly as they did and done it safely.

[Dr. Antonietta Gatti](#)

Dr. Antonietta Gatti, who is a physicist and bioengineer talks about the nano-technology of the novel Covid "vaccines", which she calls "products" because they aren't vaccines. She shares numerous images as she looks at the contamination in the shots.

[Dr. Arne Burkhardt](#)

Dr. Arne Burkhardt, retired professor, pathologist, 18-year head of the Institute of Pathology in Reutlingen testifies here about his autopsies of people who died after vaccination; included in his presentation are many images of irregularities / damage in the bodies of the victims.

[Meredith Miller](#)

This is the testimony of Meredith Miller who has worked in holistic healing and coaching for years with victims of psychological abuse. In her testimony she takes a deep look at the psychological abuse caused by the Psyop that was and is at the heart of the Covid phenomenon; she goes into the Stockholm syndrome and the many ways in which the abuser / victim relationship has played out.

[Dr. Ariane Bilheran](#)

This is the testimony of Dr. Ariane Bilheran who is a clinical psychologist and doctor in psychopathology, specializing in the study of manipulation, harassment, and totalitarianism. In her testimony she looks at what she describes, regarding what is currently happening, as "totalitarian drift."

Day 5

[Patrick Wood](#)

Patrick Wood, who has written books and numerous articles on the theme of technocracy gives his testimony. He talks about how the technocracy movement in the early 20th century was rejected but since then the technocrats have been re-inventing it and are trying to carry it to its conclusion, complete control over every aspect of our lives.

[Leslie Manookian](#)

Leslie Manookian, former investment banker with Goldman Sachs and Alliance Capital testifies. She addresses the question, "why now?", exposing how the banks worldwide have extended themselves to the point that the system must soon collapse. "What we are experiencing is a controlled demolition" of the system so those in control can stay in control.

[Björn Pirrwitz](#)

Björn Pirrwitz, lawyer and finance expert testifies. He agrees with Leslie Manookian's belief that the banking system collapse is near and looks at the future the elites have planned for us: Central Bank Digital Currency, universal digital ID, Universal income, while they own all the real assets.

[Christian Kreiss](#)

Christian Kreiss, a professor of economics, focused on the dramatic increase in the wealth gap between the top 1% and the rest of us. At about 20 minutes, just as he was pointing out that it's not purely about money but an assault on spirituality, he lost his connection. While waiting for him to reconnect several members of the panel expanded on their views that this is an existential battle of caring spirituality versus evil.

Day 6

[Patrick Wood Testimony on Transhumanism for the Grand Jury](#)

Patrick Wood, expert on technocracy, testifies again, this time on technocracy's sister, transhumanism. He looks at the Biodiversity Convention in 1992 in Brazil and Agenda 21 and the NBIC convergence and how the technocrats now have the technology to play God with the genetics of Nature.

Ilana Rachel Daniel, an Israeli health and safety researcher, testifies how Israel was a preplanned testing ground for the rollout of the injections.
