## Preface

The Source PDFs in this series will differ from my “Global Coup Related Specific Topic PDFs” that cover topics with narrative, quotes from sources, and linked footnotes. The intention is for these source documents to have a minimum of text. The idea is to assemble a library of sources for a broad spectrum of Global Coup related topics.

I have not vetted all of the information contained in the linked-to reports, articles, and videos. As always don't take my or anybody's word for anything outright. Realize your own agency and recognize that trust in information can be nuanced.

## Overview

This PDF will be in four parts.

The first part, *Vaccine Injury Data Sources*, will provide sources for information (data) about adverse events, the fallout from the Covid injections, which can be used as an ongoing reference for those wishing to go deeper and do their own analysis.

The second part, *Reports Based on and Interpretation of the Data*, will provide links to websites (individuals and organizations) who are digging into the data themselves. This includes analysis and studies.

The third part, *Testimonials*, will be links to many sites that feature individuals' testimonies about their experiences after getting the injection.

The fourth part, *Articles and Videos*, is links to material related to the injections' fallout. Included are several sections about specific issues.

## Several Notes

Note that the second, third, and fourth parts are all just a sampling of reports, studies, articles, and videos. I believe some of the more important voices are represented here but

the selection is necessarily limited by space and my personal awareness. Luckily, many of the included sources have many links to more sources.

Note, however, that all too often, links to "official" sites may turn out to be dead links. Information is being scrubbed regularly. Likewise some private sites may also get taken down as censorship rages on. Please see the last section in this document, [Accessing Dead or Disappeared Links](#), about the Time Machine and ways to retrieve lost web pages.

Note that the word "vaccination" in the title is in quotation marks to emphasize that many of the Covid shots (the mRNA and Adenovirus Genetic) are not vaccines by the long standing definition of vaccines. Semantics aside, this is about the injections going into the arms of people all around the world and for the most part will be referred to as injections in this paper.

Finally, a personal note: Statistics fascinate me but baffle me. I've heard it said that "you can torture any confession out of a statistic". Though the evidence seems to overwhelmingly show that the injections are responsible for an unprecedented amount of adverse events, this paper will endeavor to refrain from conclusions and just present information. Having said that it will link to sources and videos that I have, with my bias, chosen to offer because I think they are sources of integrity. But don't trust me. Make up your own mind.

And dear reader, please consider the information that I present from the sources as a tease intended to draw you into further exploring on your own.

## The Bigger Picture

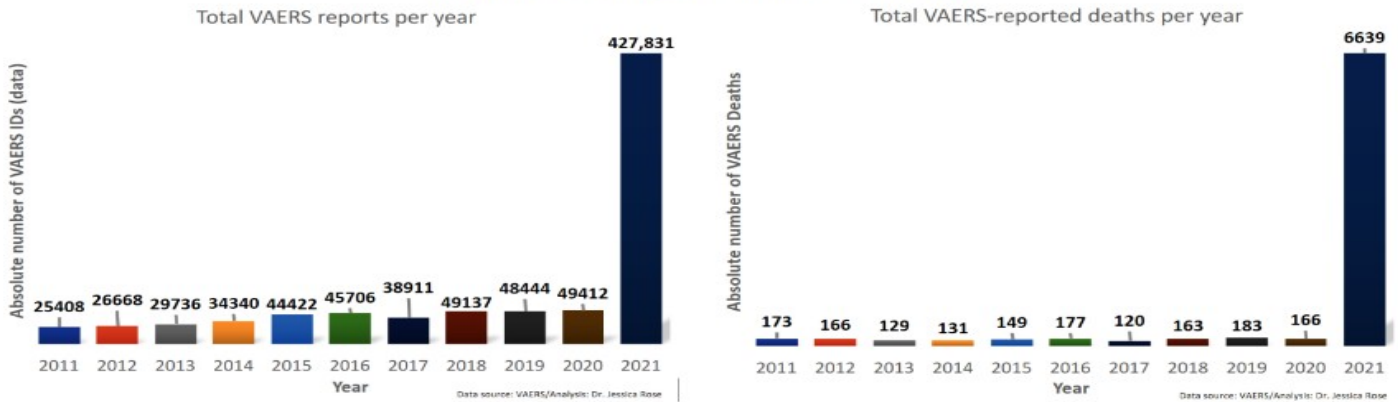

## In What Countries are the Different Kinds of Vaccine Being Used

First, to better appraise the fallout from the injections we should know from which country the reports are coming and which type of injection or injections are being used in that country as there are several different technologies being used to manufacture them, some using more traditional vaccine technology and some using exotic genetic technology.

Information on the Wikipedia website. For each of the 34 vaccines it lists, it shows a map of where they are being used and a list of the countries using it.

The vaccines are shown below by type as indicated in the article. The description of each type of vaccine comes from their respective Wikipedia articles.

- 1) Inactivated Virus Vaccine: Sinopharm BIBP, CoronaVac, Covaxin, Sinopharm WIBP, QazCovid-in, Minhai, CoviVac, COVIran Barekat, Chinese Academy of Medical Sciences, Fakhravac, Turkovac, VLA2001.

An inactivated vaccine is a vaccine consisting of virus particles, bacteria, or other pathogens that have been grown in culture and then killed to destroy disease-producing capacity.

- 2) mRNA Vaccine: Pfizer-BioNTech, Moderna.

An mRNA vaccine uses a copy of a molecule called messenger RNA (mRNA) to produce an immune response. The vaccine delivers molecules of antigen-encoding mRNA into immune cells, which use the designed mRNA as a blueprint to build foreign protein that would normally be produced by the virus. These protein molecules stimulate an adaptive immune response that teaches the body to identify and destroy the virus.

- 3) DNA Vaccine: ZyCoV-D.

DNA vaccines work by injecting genetically engineered plasmid containing the DNA sequence encoding the antigen(s) against which an immune response is sought, so the cells directly produce the antigen, thus causing a protective immunological response.

- 4) Viral Vector (adenovirus vector) Vaccine: Oxford-AstraZeneca, Janssen-Johnson and Johnson, Sputnik-V, Sputnik Light, Convidecia.

A viral vector vaccine is a vaccine that uses a viral vector to deliver genetic material coding for a desired antigen into the recipient's host cells.

- 5) Subunit (various types): Novavax, Abdala, EpiVacCorona, Zifivax, Soberana 02, Medigen, COVAX-19, Razi Cov Pars, Sinopharm CNBG, Corbevax, Soberana Plus, CoVLP (GSK), Noora, Sanofi-GSK, SCB-2019.

A subunit vaccine contains purified parts of the pathogen that are antigenic, or necessary to elicit a protective immune response. A "subunit" vaccine doesn't contain the whole pathogen, unlike live attenuated or inactivated vaccine, but contains only the antigenic parts such as proteins, polysaccharides or peptides.

## *Data Sources*

### VAERS, the Vaccine Adverse Event Reporting System

In the United States VAERS is a major source for information about adverse events from vaccines. VAERS stands for Vaccine Adverse Event Reporting System. It is a part of the CDC and the statistics are to be found on the CDC's website.

#### [VAERS Vaccine Adverse Event Reporting System](#)

From the About page on the CDC website::

Established in 1990, the Vaccine Adverse Event Reporting System (VAERS) is a national early warning system to detect possible safety problems in U.S.-licensed vaccines.

How VAERS works from the About page:

VAERS accepts and analyzes reports of adverse events (possible side effects) after a person has received a vaccination. Anyone can report an adverse event to VAERS. Healthcare professionals are required to report certain adverse events and vaccine manufacturers are required to report all adverse events that come to their attention.

VAERS is a passive reporting system, meaning it relies on individuals to send in reports of their experiences to CDC and FDA. VAERS is not designed to determine if a vaccine caused a health problem, but is especially useful for detecting unusual or unexpected patterns of adverse event reporting that might indicate a possible safety problem with a vaccine.

### How Accurate is VAERS

VAERS statistics are certainly not exact, unlike data from a carefully overseen controlled study. Some insist that the actual number of events are much higher because, of course, not all are reported. While others maintain the actual numbers of events are

lower because the reports can't be verified; appraisal of a medical condition is always subjective and one can never show 100% that the injection was the cause.

"Underreporting" is one of the main limitations of passive surveillance systems, including VAERS. The term, underreporting refers to the fact that VAERS receives reports for only a small fraction of actual adverse events.

Further it [the Lazarus Report] [see the next link] states, "Adverse events from drugs and vaccines are common, but underreported. Although 25% of ambulatory patients experience an adverse drug event, less than 0.3% of all adverse drug events and 1-13% of serious events are reported to the Food and Drug Administration (FDA). Likewise, fewer than 1% of vaccine adverse events are reported."

## *Data from the Defense Military Epidemiology Database (DMED) Exposed by Whistleblowers*

This section is about something that is a much bigger story than will be presented here but deserves mention in this paper. It's about what appears to be a massive deception on the part of the Department of Defense.

The Department of Defense has its own system for tracking health and medical issues of service members, the *Defense Military Epidemiology Database* (which is linked to in the first part of this PDF).

Three whistleblowers, late 2021, came forward with evidence from the DMED of a dramatic increase in registered diagnoses of serious medical issues. After the DoD became aware of the evidence being released, they claimed the numbers the

whistleblowers revealed were correct but the system had somehow been malfunctioning and had been showing numbers that were too low for the previous 5 years (the 5 years the whistleblowers were comparing 2021 with). And that now the data has been corrected and those apparently extraordinarily high numbers revealed by the whistleblowers were actually just normal.
