## Preface

What is the Young Global Leaders program? Started in 1992 by Klaus Schwab, founder and head of the World Economic Forum, initially called the Global Leaders of Tomorrow, and becoming the Forum of Young Global Leaders in 2004, it is essentially a school for people groomed to make a difference in the world, aligned with the World Economic Forum's vision. From the Young Global Leaders' About page:

We identify and champion ways to scale-up, amplify and accelerate their impact, to make more of a difference in their communities and beyond.

The names in these lists were collected from a number of sources which I have then verified as having been in the program on either the Young Global Leaders website, the World Economic Forum's website, or the WikiSpooks website. (Neither the WEF nor the YGL websites currently publish full lists from earlier than 2016.) The names are grouped (see the Table of Contents) and within the groups are sorted by country in some instances and by company or association in others or just by name. All names are only listed once in spite of many résumés fitting into multiple categories.

The date in parenthesis after each person's description is the year of their class; most of the dates are from WikiSpooks as it's not shown on the YGL website by a name search.


Some of the descriptions come from the Young Global Leaders website and some from the World Economic Forum website but most of the descriptions come from WikiSpooks and/or Wikipedia, as well as some tracked down from other sources. Note that many of these people have held so many positions and/or are involved in so many ventures that their descriptions are necessarily truncated. If no date is mentioned regarding a particular office or position it may or may not be current.

As always, don't take my or anybody's word as to the absolute verity of the information. Do your own research if you want to get more information to fill out the picture and remember that trust in information is nuanced.
